







#### Jones Act "Google Trends" ('04 – present)

#### 1) The Jones Act does not apply

- The Jones Act does not apply outside of 3 miles.
- The Deepwater Horizon rig is 50 miles from shore.

# 2) Special provisions in cases like this for oil spill response vessels in an emergency (46 U.S.C. 55113)

- Can use a foreign skimmer anywhere
- If there are not an adequate number of U.S. vessels (so declared on June 16), and
- If the flag state nation has reciprocal laws.

#### 3) Expedited Jones Act waivers


 Jones Act can always be waived if no U.S. vessel is available

 National Incident Command announces "accelerated processing for any waiver requests" (June 15, 2010)


#### 4) Foreign skimmers are participating

- 22 offers of assistance from 12 foreign countries, as of June 29, 2010.
- Assets used from Belgium, Canada, China, France, Germany, Ireland, Japan, Kenya, Mexico, Netherlands, Norway, Qatar, Russia, Spain, Tunisia, United Arab Emirates, United Kingdom, the United Nations' International Maritime Organization, the European Union's Monitoring and Information Centre, and the European Maritime Safety Agency. "We <u>at no time</u> in the course of this response have been inhibited by anything we have to do with what we call the Jones Act ... All of the [foreign] vessels that are operating outside of three miles do not require Jones Act waivers."


